
Privacy Policy GDPR

1. BACKGROUND

1.1 UM Association Limited (UMAL), Hasilwood Management Services Limited (HMSL) and UM Association (Special Risks) Ltd (UMSR) each of which has its registered office at 5 St Helen's Place, London EC3A 6AB, collect and use certain Personal Data. UMAL is responsible for ensuring that it uses that Personal Data in compliance with data protection laws.

1.2 At UMAL we respect the privacy of our clients and we are committed to keeping all your Personal Data secure. This Privacy Policy governs the handling of Personal Data by UMAL in the course of carrying on commercial activities.

1.3 We use the following definitions in this Privacy Policy:

"UMAL", "we or us" means UMAL and the other companies referred to in paragraph 1.1 above.

"Personal Data" means any data which relates to a living individual who can be identified from that data or from that data and other information which is in the possession of, or is likely to come into the possession of, UMAL (or its representatives or service providers). In addition to factual information, it includes any expression of opinion about an individual and any indication of the intentions of UMAL or any other person in respect of an individual.

2. THE PRODUCTS AND SERVICES WE PROVIDE

2.1 This Privacy Policy concerns the following categories of information that we collect about you when providing the following products and services:

- (A) Information we receive through our website ("**UMAL Website**");
- (B) Information we receive through our products ("**UMAL Products**");
- (C) Information we receive through our support, mobile security solution or cloud-based services ("**UMAL Services**").

3. THE TYPES OF PERSONAL DATA WE COLLECT

3.1 Many of the services offered by UMAL require us to obtain Personal Data about you in order to perform the services we have been engaged to provide. In relation to each of the services described at paragraph 2.1 above, we will collect and process the following Personal Data about you:

- **Information that you provide to UMAL.** This includes information about you that you provide to us. The nature of the services you are requesting will determine the kind of Personal Data we might ask for, though such information may include (by way of a non- exhaustive list):

- basic Personal Data (such as first name; family name; position in the company; company name; company email address; business phone number; business address; city; postcode; country);
 - any information that you choose to share on UMAL internet forums which may be considered Personal Data. Please note that UMAL does not combine information that you choose to share on UMAL internet forums together with other Personal Data;
- **Information that we collect or generate about you.** This includes (by way of non-exhaustive list):
 - a file with your contact history to be used for enquiry purposes so that we may ensure that you are satisfied with the services which we have provided to you;
 - through our cloud security services, traffic and security reports that include information on the internet usage of the organisation's computer users (e.g. what websites were visited by each user, any documents downloaded, security incidents, prevention measures taken by the gateway, etc.); and
 - activity data relating to the use of protected documents, such as altering a document's permissions and information regarding the individual that performed the activity.
 - **Information we obtain from other sources.**
 - This includes the Personal Data provided to us by our members, third-party service providers, agencies or other publicly available sources (including social media sources) where applicable.
 - **Cookies**
 - When you visit UMAL's Website, cookies are used to collect technical information about the services that you use, and how you use them.
 - For more information on the cookies used by UMAL please see our Cookie Notice.
 - **Anonymised data**
 - In addition to the categories of Personal Data described above, UMAL will also process further anonymised information and data that is not processed by reference to a specific individual.

4. HOW WE USE YOUR INFORMATION

4.1 Your Personal Data may be stored and processed by us in the following ways and for the following purposes:

- for ongoing review and improvement of the information provided on UMAL's Website to ensure they are user-friendly and to prevent any potential disruptions or cyber-attacks;
- to allow you to use and access the functionality provided by the UMAL Products;
- to assess your application for UMAL Products, where applicable;
- to set up users to use UMAL Products;
- to conduct analysis required to detect malicious data and understand how this may affect your IT system;
- to investigate the facts and circumstances relating to any incidents involving you or claims which you have made against our members;
- for statistical monitoring and analysis of current attacks on devices and systems and for the on-going adaptation of the solutions provided to secure devices and systems against current attacks;

- to understand feedback on UMAL Products and to help provide more information on the use of those products and services quickly and easily;
- to communicate with you in order to provide you with services or information about UMAL and UMAL Products;
- for in-depth threat analysis;
- to understand your needs and interests;
- for the management and administration of our business;
- in order to comply with and in order to assess compliance with applicable laws, rules and regulations, and internal policies and procedures; or
- for the administration and maintenance of databases storing Personal Data.

4.2 However, we use Personal Data we make sure that the usage complies with law and the law allows us and requires us to use Personal Data for a variety of reasons. These include:

- we need to do so in order to perform its contractual obligations with its customers;
- we have obtained your consent;
- we have legal and regulatory obligations that we have to discharge;
- we may need to do so in order to establish, exercise or defend our legal rights or for the purpose of legal proceedings;
- the use of your Personal Data as described is necessary for our legitimate business interests, such as:
 - allowing us to effectively and efficiently manage and administer the operation of our business;
 - maintaining compliance with internal policies and procedures;
 - monitoring the use of our copyrighted materials;
 - enabling quick and easy access to information on UMAL Products;
 - offering optimal, up-to-date security solutions for mobile devices and IT systems; and
 - obtaining further knowledge of current threats to network security in order to update our security solutions and provide these to the market.

4.3 Where required for the purposes set out in this paragraph 4, in some circumstances we collect personal data relating to your health, political or religious beliefs, sexual life and orientation or trade union membership. We may also collect biometric, genetic and criminal records and conviction information for those purposes. Where we collect any of the categories of personal data listed above, we only do so:

- with your explicit prior consent;
- where it is necessary for us to do so to for the establishment, exercise or defence of legal claims or whenever courts are acting in their judicial capacity; or
- where it is otherwise lawful for us to do so.

4.4 We will take steps to ensure that the Personal Data is accessed only by employees of UMAL that have a need to do so for the purposes described in this Privacy Policy.

5. DISCLOSURE OF YOUR INFORMATION TO THIRD PARTIES

5.1 We may share your Personal Data within the UMAL group for the purposes described above.

5.2 We may also share your Personal Data outside of the UMAL group for the following purposes:

- with our business partners. For example, this could include our partners from whom you or your company or your organisation purchased the UMAL product(s). Personal Data will only be transferred to a business partner who is contractually obliged to comply with appropriate data protection obligations and the relevant privacy and confidentiality legislation;
- with third party agents and contractors for the purposes of providing services to us (for example, UMAL's accountants, professional advisors, IT and communications providers and debt collectors). These third parties will be subject to appropriate data protection obligations and they will only use your Personal Data as described in this Privacy Policy;
- to the extent required by law, for example if we are under a duty to disclose your Personal Data in order to comply with any legal obligation (including, without limitation, in order to comply with tax reporting requirements and disclosures to regulators), or to establish, exercise or defend its legal rights;
- if we sell our business or assets, in which case we may need to disclose your Personal Data to the prospective buyer for due diligence purposes; and
- if we are acquired by a third party, in which case the Personal Data held by us about you will be disclosed to the third party buyer.

6. INTERNATIONAL TRANSFERS OF PERSONAL DATA

6.1 UMAL is not a global business, neither are our Members. We do not therefore collect and transfer Personal Data on a global basis, and we do not transfer your Personal Data to locations outside of the United Kingdom.

6.2 If however we do need to transfer your Personal Data to another country outside the United Kingdom, we will ensure that it is protected and transferred in a manner consistent with legal requirements. In relation to data being transferred outside of the United Kingdom, for example, this may be done in one of the following ways:

- the country that we send the data to might be approved by the UK Government as offering an adequate level of protection for Personal Data (for example, Israel is an approved country);
- the recipient might have signed up to a contract based on "model contractual clauses" approved by the UK Government, obliging them to protect your Personal Data; or
- in other circumstances the law may permit us to otherwise transfer your Personal Data outside Europe.

- 6.3 You can obtain more details of the protection given to your Personal Data if it is transferred outside the United Kingdom (including a copy of the standard data protection clauses which we have entered into with recipients of your Personal Data) by contacting us as described in paragraph 11 below.

7. HOW WE SAFEGUARD YOUR INFORMATION

- 7.1 We have extensive controls in place to maintain the security of our information and information systems. Client files are protected with safeguards according to the sensitivity of the relevant information. Appropriate controls (such as restricted access) are placed on our computer systems. Physical access to areas where Personal Data is gathered, processed or stored is limited to authorised employees.
- 7.2 As a condition of employment, UMAL employees are required to follow all applicable laws and regulations, including in relation to data protection law. Access to sensitive Personal Data is limited to those employees who need access to it to perform their roles. Unauthorised use or disclosure of confidential client information by a UMAL employee is prohibited and may result in disciplinary measures.
- 7.3 When you contact a UMAL employee about your file, you may be asked for some Personal Data. This type of safeguard is designed to ensure that only you, or someone authorised by you, has access to your file.

8. HOW LONG WE KEEP YOUR PERSONAL DATA

- 8.1 How long we will hold your Personal Data for will vary and will be determined by the following criteria:
- the purpose for which we are using it – UMAL will need to keep the data for as long as is necessary for that purpose; and
 - legal obligations – laws or regulation may set a minimum period for which we have to keep your Personal Data.

9. YOUR RIGHTS

- 9.1 In all the above cases in which we collect, use or store your Personal Data, you may have the following rights and, in most cases, you can exercise them free of charge. These rights include:
- the right to obtain information regarding the processing of your Personal Data and access to the Personal Data which we hold about you;

- the right to withdraw your consent to the processing of your Personal Data at any time. Please note, however, that we may still be entitled to process your Personal Data if we have another legitimate reason for doing so. For example, we may need to retain Personal Data to comply with a legal obligation;
- in some circumstances, the right to receive some Personal Data in a structured, commonly used and machine-readable format and/or request that we transmit those data to a third party where this is technically feasible. Please note that this right only applies to Personal Data which you have provided directly to UMAL;
- the right to request that we rectify your Personal Data if it is inaccurate or incomplete;
- the right to request that we erase your Personal Data in certain circumstances. Please note that there may be circumstances where you ask us to erase your Personal Data but we are legally entitled to retain it;
- the right to object to, or request that we restrict, our processing of your Personal Data in certain circumstances. Again, there may be circumstances where you object to, or ask us to restrict, our processing of your Personal Data but we are legally entitled to refuse that request; and
- the right to lodge a complaint with the relevant data protection regulator if you think that any of your rights have been infringed by us.
